

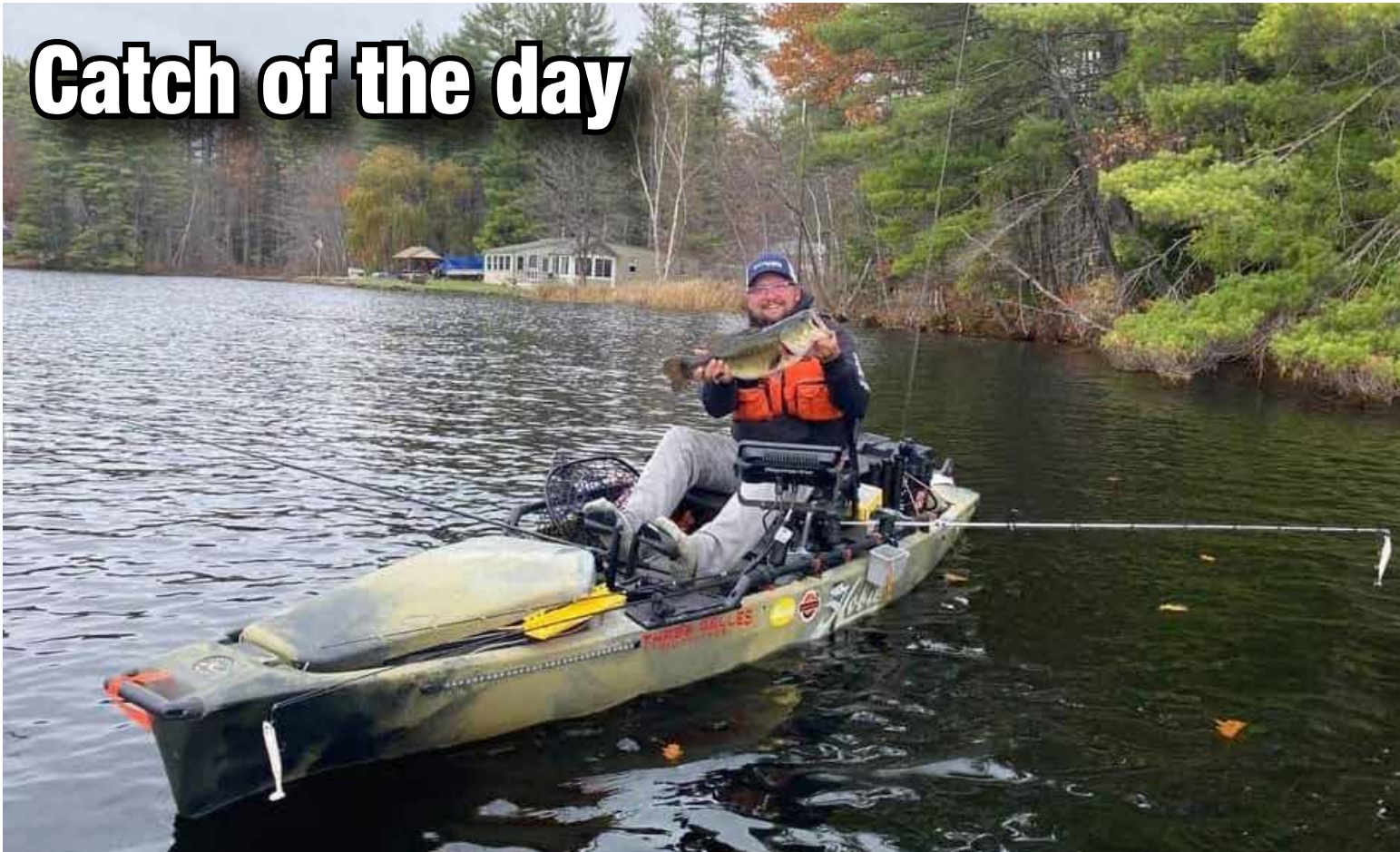

Solar plans for Newfield

NBD Solar Maine LLC has filed an application with the Newfield Planning Board for a Conditional Use Permit to put in a solar facility at 66 Water Street, in West Newfield at the site of the former Moulton Lumber, Map 22 Lot 4.1.

According to the Project Manager, Shawn Tobey, of Hoyle, Tanner and Assoc., Inc. of Hanover, New Hampshire, the proposed facility will be a green renewable energy system for reducing emissions. However, there are several items that need to be addressed prior to approval.

The project conforms to all town regulations which are outlined in the Newfield Zoning Ordinance. It supports Maine's greener energy and is for the betterment of the town, according to the first phase of the permit process.

It will be a ground mounted facility on 15 acres of the property, which will provide electrical energy to the town. The development of the facility will have no expense to the town and no safety hazards.

In the application it states that there is no threat to endangered wildlife or their habitats

The Newfield Planning Board holds public hearings on the entire process, which can be viewed on Zoom. At this point they are on stage 2 of the process. Also the minutes of the hearings can be read on the town website under the Planning Board.

They have monthly meetings on the first Wednesday of the month at the West Newfield Town Hall. The public is welcome to attend.

We reached out to the developers, but did not get a reply. If they are approved for this project, we will report more on exactly when they will be starting and how long they expect it to take.

Maine rental relief COVID-19 program

Popular Christmas fairs go virtual

Like most popular events that highlight the holiday calendars of community members, Christmas fairs will look different this year due to the pandemic.

"The pandemic has affected everyone and some will not be able to donate to our Christmas fairs this year," said Fr. Scott Mower, pastor of the Parish of the Ascension of the Lord (St. Raphael Church, Kittery; St. Christopher Church, York; Our Lady of the Angels Church, South Berwick; and Star of the Sea Church, York Beach). "Even during these challenging times, we are still working to continue our mission."

The spirit and parish financial support generated by the fairs remain, only this year, it moves from decorated parish halls and churches to a virtual forum.

"We are asking parishioners who can donate this year to support businesses that have supported our parish," said Fr. Mower. "We are listing the businesses on our website under each of the

The World of George Came

I never met George Came but I knew him quite well. I knew where he lived, I knew about his family and friends and his likes and dislikes. I knew all these things because George kept journals. He was a faithful reporter of what happened in Alfred in the later years of the 1800's.

Because he was such a careful recorder of those years, his journals became an informal history of Alfred. The Comes lived on Back Road, farming the same acres their father had farmed. There was his brother Sam, a lawyer, who built a spacious home in the village. Sisters Mary Hannah and Sarah, known as "Sade", lived at home, continuing to care for the home and to provide the meals for George. The sisters never married. Nephew Walter also became a lawyer and also enjoyed "journaling" but not done quite as thoroughly as George. Walter moved to Massachusetts after grad-

uation. His sister Grace rounded out the family.

I cannot remember who first decided to copy the journals, but when they were copied the library was given a set and because I wanted a set for myself for reference purposes, I purchased it when the journals were copied. There is also a set in the Alfred Village Museum. Anyone can read them but they may not be taken out which means the set has remained complete. The diaries of Walter Littlefield Came were transcribed by Louise Gray and myself.

The Came journals aren't the only clues in the museum to Alfred's past. General Samuel Leighton, who ran the Alfred House across from the courthouse, also kept journals, numbering six volumes of village activities in what was actually a hotel. Then there was Eliab Littlefield who traveled in the South before the Civil War in hopes of improving his health. His letters home were kept by Susan, his wife, and the first is dated 1830. He died in 1845 after returning home. The letters were found in the house by Helen Bragdon who bought the house, and were transcribed by her. She stated Eliab had traveled by railroad, stage coach, river steamboat and canal boat. His observations of the prewar South are extremely interesting and Helen did a meticulous job

of copying the letters. Eliab's sons later opened a store in what is now DeWolf and Wood Antiquarians.

When I did the genealogy of my mother's family, I realized just dates and names would not be enough. What were they like? What were the outstanding events in their lifetimes?

There was certainly enough material available. Great Aunt Bertha was a hoarder – of letters, books, postcards, etc. She could not part with anything having to do with the family. So I read the letters and became intimately acquainted with them all. I also did the genealogy of my father's family, as much of it as I was able. It was disappointing in many ways because they were NOT hoarders. They lived interesting lives but left fewer traces behind them. I would love to know more about the one who headed west during the gold rush, and returned home with gold nuggets in his pocket. Or my uncle who gave up being a sea captain to go fishing. And how about that cousin who opened a studio in St. John N.B. and had a photo taken of herself and her very long tresses? Or John Henry Finch who according to my father died with his boots on? Years later I learned there was no John Henry, just John and Henry, brothers who probably did die with their boots on because they were fishermen. There were no written stories, but my mother's family were writers – letters were saved from one generation to the next.

The letters were revealing. I included all of them. It makes the genealogies much more interesting (and very lengthy.) By the time I finished I felt I knew them very well indeed. Some parts are quite comical – my great-grandmother reminding my grandfather to brush his teeth, keep well shaven and his feet clean while he is in college. They were faithful churchgoers so there are comments about the sermons and church activities. When my

Baseball's Hall of Fame shame

You've probably never heard the name Henry John 'Zeke' Bonura, before. He was a United States Army Veteran who served his country in World War II. He was Born in New Orleans in the fall of 1908 and first drew national attention as a 16-year-old high school

American and British forces. In spite of all of this, Bonura began organizing baseball teams amongst different allied forces spread across Africa. By the time he entered Algeria in the spring of '43, he found himself supervising some 150 teams in six

Bonura returned to baseball after the war, but his numbers diminished. He died in 1987 at the age of 78 in New Orleans. I recently reached out to Baseball's Hall of Fame wanting to know why Bonura is not in Cooperstown. Craig Muder, the Communications Director of the Hall of Fame, quickly pointed out 'The rules dictate a player must have at least 10 years of service in the Major Leagues to qualify for the Hall. The war ended Bonuras' career in his seventh year.

There is no WWII exhibit in Cooperstown. John 'Zeke' Bonura brought baseball to Africa during the darkest period of the 20th century. He kept alive the hopes, determination and drive of many allied forces from two different continents. With Veterans Day upon us, it's hard for me to imagine there isn't a place in Cooperstown for Bonura, or a display featuring the 150 baseball teams playing their way through a horrible war. Bonura and Veterans all across this nation have a done a great service for the people of this country. It seems as if MLB is doing a dis-service to a leader amongst veterans, a career .307 hitter who sacrificed three more years in the majors for 5 years at war.

different leagues. By summers end Rommel returned to Germany signaling the inevitable fall of Germany in Africa. By the time fall rolled around 150 teams had been whittled down to 2 and the first North African World Series got under way. It pitted the Algiers Streetwalkers against the Casablanca Yankees'. In a tight series, the Yankee's walked off with the African World Series Trophy. Redsox fans take note: the trophy awarded to the Casablanca Yankees' just happened to be an unexploded bomb dropped from enemy aircraft.

Bonura stayed in Africa through 1945 and even formed an all Arab-league, but the league fell apart when players learned a key element of the game involved base-stealing. Stealing anything is against Islamic Law and so ended the Arab Baseball League of North Africa. His wartime baseball achievements received recognition from Eisenhower for its immensely positive effect on troop morale.

student participating in a Track and Field program. What did he do? He became the youngest athlete ever to win an event at the National Track and Field Championship. He accomplished this by throwing a Javelin some 213 feet, setting the all-time record in the Javelin throwing competition. The record would stand for the next several years.

Bonura, of course, graduated high school and moved onto college, attending the University of New Orleans where he became the best basketball forward the Loyola Wolfpack had ever seen. But this isn't a Basketball story. This is actually a baseball story and the story of a Veteran who served his Country in a devastating war.

When it comes to Baseball and more importantly, baseball in Chicago, one can't come up with a whole lot to say about the Chicago White Sox. Baseball in Chicago belongs to the Chicago Cubs with their 107-year world series drought blamed on a goat before it came to an end in 2016. When it comes to the Chicago White Sox all one can say about the team is they changed their name from The Chicago Black Sox, because the Black Sox were involved in the greatest baseball scandal of all time. They agreed to throw a World Series. Since then, the only good thing to come out of a White Sox uniform is Hall of Famers Frank Thomas, Goose Gossage, Tim Lincecum and Harold Baines. Zeke 'Banana Nose' Bonura, who managed his way from a slam-dunk on a New Orleans basketball court to first base for the Chicago White Sox, hit a record 114 homeruns for the franchise. The record still stands today.

The Japanese interrupted Bonuras' baseball career when they bombed Pearl Harbor. Hitler and Mussolini aligned themselves with the Japanese. Every able-bodied man in America signed up to defend the country and preserve our Democracy from the authoritarian regimes determined to wipe out freedom. Bonura traded his Whitesox uniform for Army green and soon found himself fighting in North Africa where Allied Forces were being pushed to the brink by men with names like Montgomery and Patton in a race to chase German Commander Rommel into the history books. But this isn't a story about the war. This is a story of the Chicago White Sox leading homerun hitter and the 500 plus troops who followed his lead.

Rommel and the Germans were putting up a remarkable fight with
